

The National Digital Literacy Programme and the PLD Initiative

An Overview

The National Digital Literacy Programme (NDLP)

- The NDLP was launched in March 2020 to make digital learning inclusive by equipping students with the digital skills to be futureready.
- 2. Under the NDLP, every secondary school student will **own a school-prescribed personal learning device (PLD)**. Students may use funds from their Edusave Account to pay for the PLD.

Supporting Students in the Safe and Effective Use of the Devices

The school has measures in place to enable a safer digital environment for learning with the use of PLDs, e.g.


- Classroom Management and Routines: Acceptable Use Policy
- Educating students on Cyber Wellness
- Partnering parents/guardians to ensure that students are well-supported in their use of technology for learning
- Device Management Application (DMA)

Classroom Management and Routines: Acceptable Use Policy (AUP)

- Parents could refer to the AUP when helping to manage his/her child's use of the PLD. The AUP will help your child to understand the expectations of device use to enable a conducive learning environment.
- It also **outlines** the **consequences** for violating the policy.

CHIJ St. Theresa's Convent's

Acceptable Use Policy (AUP) in student



This policy applies to all computing Personal Learning Devices (PLDs), school's ICT facilities, equipment and resources used at CHIJ St. Theresa's Convent by students, staff or guests. The policy also applies to any other device considered by the School to fall under this policy.

Teachers may set additional requirements on the use of the PLDs as required for the conduct of their lessons

ICT facilities, equipment and resources include the following, but are not limited to, school's internet network, Computer Labs, hardware (e.g. laptops, tablets, computers), software (e.g. school's learning management system, productivity software, online tools) and peripherals (e.g. projector, scanner, cameral).

General

- Students are responsible for their PLDs. The school will not be held responsible for any damage, theft or loss of their devices, in the event of loss or theft of devices, students must make a police report and report the matter to the school.
- PLDs should be safely kept away and not left unattended. Students should lock their PLDs in their lockers when not in use for a period of time
- PLDs can only be used during curriculum time in the classroom under the instruction of the teacher.
- Permission must be sought from your teacher to go to the locker to lock or retrieve the PLD.
- Students should ensure that their PLDs are fully charged before bringing them to school. Students are not allowed to charge their PLDs in the classrooms.
- Students should bring their PLDs home with them at the end of every school day.
- 7. Students' PLDs are installed with device management application software. When enrolled, the software will manage students' device usage based on settings determined by the school. Students should not attempt to uninstall or de-enroll themselves from the software. Any violation might lead to disciplinary action in accordance to the school's discipline policy.

- Students are responsible for using school-owned ICT facilities, equipment
 and resources for the purpose of learning. Personal use such as gaming,
 aambling and engaging in social media platforms is strictly prohibited.
- Students are responsible for any resource that is borrowed from school
 for the duration of the loan. The user will bear the cost of damage, theft
 or loss due to negligence and face disciplinary action in accordance to
 the school's discipline policy.

Account

- 10.Students are responsible and accountable for all activities conducted via their own accounts.
- Students are responsible for the security of their account IDs and passwords. All account IDs and passwords should not be shared with anyone.
- Users should change their passwords every 6 months. Failure to do so would constitute as negligence.
- Students are to use their full name as stated in their EZlink cards for all account IDs. Aliases, nicknames and pseudonyms are not allowed.
- 14.Students should not use their accounts for any illegal or unethical activities. These include posting online remarks that are racially and religiously insensitive, vulgar and/or offensive statements, disruptive of public order and intentionally causing emotional distress/harm to others.
- 15. The computing devices are meant for educational use only. Students should not use them for purposes beyond teaching and learning e.g. gaming, any online trade (i.e. buying and selling of goods and services).
- 16.Students should not use devices to store, modify or create content (e.g. documents, presentations, pictures, videos) that is pomographic or defamatory in nature.

Email & Social Media

- 17. Students should not post or share any indecent, obscene, pornographic, defamatory material/message that offends and causes distress to other people.
- 18. Students are reminded that threats, harassment, embarrassment, impersonation and intimidation to others is a chargeable offence under the Singapore Legal System.
- 19. Students are expected to remain courteous and polite in all online interactions

Privacy and Safety

- Students should not reveal their personal details (e.g. phone number, home address, NRIC, passwords, or passwords of other people) openly online
- 21.If students inadvertently access a website that contains obscene, pornographic, or otherwise offensive material, notify a trusted adult (e.g. parents or teachers) immediately.
- 22. Any attempt to alter data, the configuration of a computer, or the files of another user, without the consent of the individual, is an act of vandalism and subject to disciplinary action in accordance with school's discipline policy.

Intellectual Property

- 23. Students should not access, download, copy or share any copyrighted materials (such as pictures, videos, music) without explicit permission
- 24. Students should not own, copy or share software in an unauthorised or illegal manner.
- 25. The rights of all materials and data created using the school's ICT facilities and resources are jointly owned by the school and the user.

The school reserves the right to record and retain data on school-owned devices and/or accounts issued by the school for investigation or evidence.

Violation of any policies, rules or administrative procedures may result in a temporary suspension or revocation of student's account. The student may also face disciplinary action in accordance to the school's discipline policy.

Parents'/Guardians' Role

- We would like to partner parents/guardians to ensure that students are well supported in their use of technology for learning.
- As parents/guardians, you can help in the following ways:
 - Model good digital habits for your child/ward e.g. parents/guardians not using devices during family meals.
 - Know your child/ward well, and have conversations with your child/ward about safe and responsible use of technology.
 - Set ground rules for internet/device usage.
 - Guide your child/ward to use productivity tools using his/her PLD, to organise information and simplify tasks for efficiency.

Role of the DMA in Providing a Safer Digital Environment for Learning

Device Management Application Installation

- Your child's/ward's PLD will be installed with a Device Management Application (DMA) to provide a safer digital environment for learning.
- Installation of the DMA will be performed after the collection of the device. Students will be guided on the installation.
- This applies to both devices purchased through the school and preexisting student-owned devices.
- The DMA will be **funded by MOE** and will be **uninstalled** from the device **when your child/ward graduates/leaves the school**.

In-School DMA Settings (Default)

Schools will determine DMA settings for **in-school use**. As a default, these settings will continue to be in place after school as well:

- MOE and the school will set the level of web content filtering, including filtering out objectionable content or content that may not be conducive to teaching and learning (e.g. social media, pornography, gambling, or websites containing extremist content)
- Students will be able to use the device from 7 a.m. to 11p.m daily
- The school will determine the apps and programs to be installed to support teaching and learning

Providing Parents/Guardians with Greater Choice for After-School PLD Use

The school will provide parents/guardians with more information on exercising the options.

- Having default school settings continue after school hours is the best option for parents/guardians
 who prefer not to, or do not feel ready to manage their child's/ward's device use on their own.
- Parents/guardians can request to change their choice of DMA settings at any time.

Deciding on the Choice of After-School DMA Option

Parents/guardians may wish to consider the following questions before deciding on the choice of after-school DMA option which is best for your child's/ward's learning.

1. Child's/ward's current device usage habits

- How much time does my child/ward spend on their device?
- How well is my child/ward able to regulate their device usage on their own?
- Does my child/ward get easily distracted while doing online learning?

2. Parents'/Guardians' involvement

- How confident and familiar am I with managing my child's/ward's cyber wellness?
- Are there existing routines and open conversations on the use of the Internet at home?
- Am I aware of how to prevent different types of cyber threats that my child/ward might face?



Have a conversation with your child/ward to talk about which setting is best for your child's/ward's learning.

Data Collected by the DMA

The DMA does **NOT** collect any of the following data:

- Login IDs and passwords entered into websites or into any applications
- Actions performed (e.g. posts, online comments, items added to a shopping cart, etc.) when visiting websites and using apps
- Documents and photos stored in the PLDs
- PLD location
- Webcam videos and microphone recordings



Collection of Devices

Your child/ward will be collecting his/her device in school is estimated to be around Apr- May 2022.

- You may arrange to collect the device at the contractor's service / collection centre* or appoint an adult proxy to do so.
- Your child/ward would need to bring the device to school and arrange for the school's IT department to install the DMA.

Please approach the school for further advice or clarification if you would like to make this arrangement.

^{*} Parents/Guardians (or adult proxy) will **not** be able to collect the PLD from the school.
